Guidelines for Enrollment in K&E Courses

The following criteria must be met:

- The student is a minimum age of 12 years 6 months upon enrollment.
- The student and their parent(s)/guardian(s) in collaboration with the school support team have determined that K&E course enrollment aligns with the students' learning needs at this time.
- The student and their parent(s)/guardian(s) in collaboration with the school support team have developed a learning plan that outlines the students' goals and course selection needed to achieve these goals.
- Annual informed written consent of the student, and if the student is under the age of 16 years, consent of the parent(s)/guardian(s).
